With intense pain that never goes away not even when I am laying down and not doing anything and no pain-killing pills or drugs help me to reduce my pain even a little.

In addition, with regards to the hearing held on January 19, 2022, I want to say that there were may irregularities that affected me and denied my disability once again. Also, many things were omitted and there were even lies to directly affect me since I personally called the doctors' office who have had me under observation since the day of my accident.

7/24/2019 I had to call my doctor Steven Killpack, MD, and he did not send any information [illegible] as was mentioned under oath by doctor Robert Henrichsen, MD, who said it at the hearing. In addition, when judge Jessica Wall asked attorney Nhung Dao regarding the disc as to the number of sheets it contained she lied on 2 occasions since the disc has 444 sheets and on 2 occasions she said 2 numbers that do not match up with the correct amount of 444 sheets that the disc has; this can be proven because the hearing was recorded (1-19-2022).

That is how I, Samuel Gonzalez Lopez am advising you that I had to call my doctor's office, Steven Killpack, MD, and they confirmed that no one had called him and that he did not send any information regarding (7/24/19).


