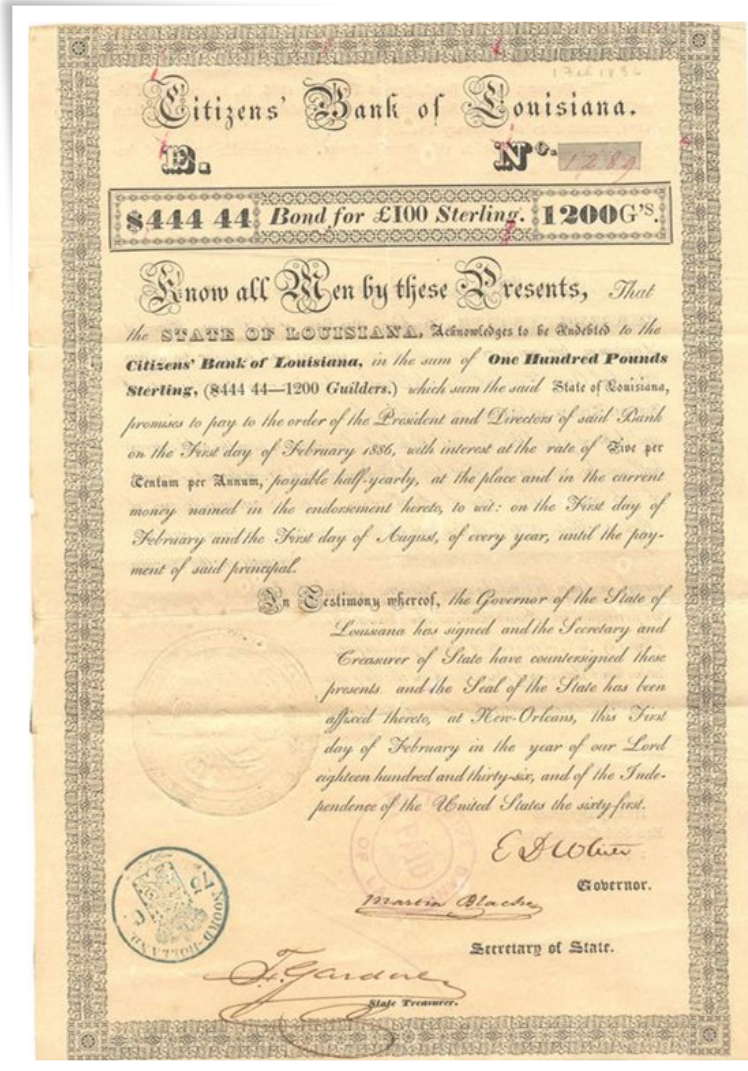

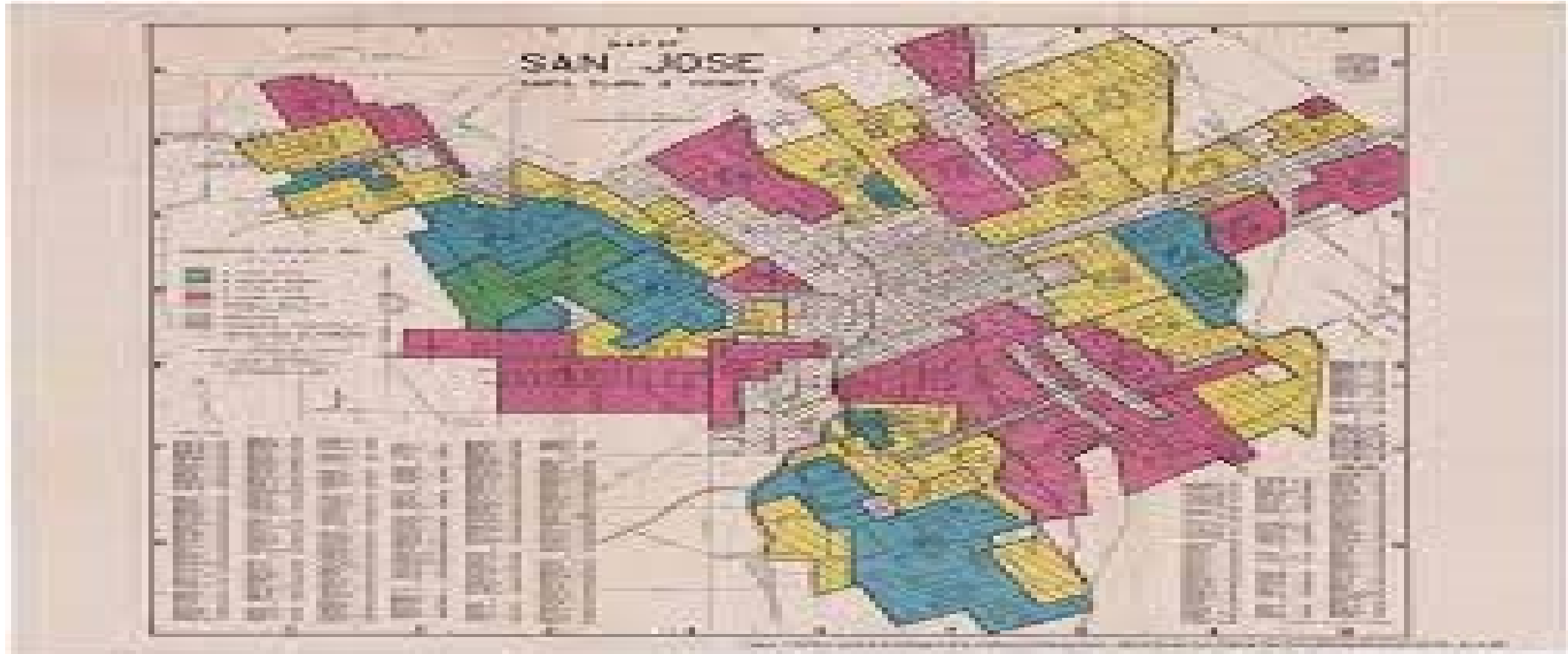

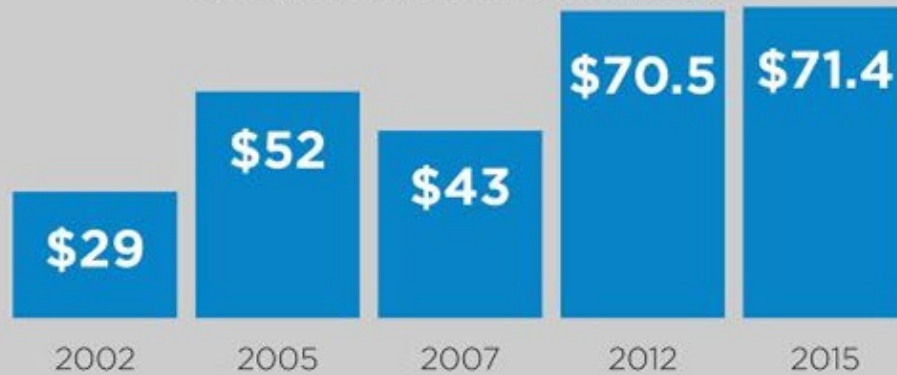

Global AUM, trillions of dollars

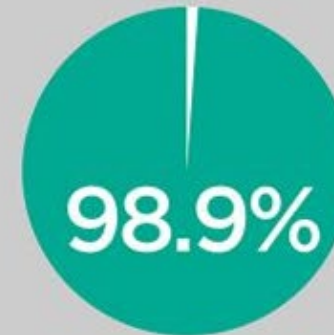

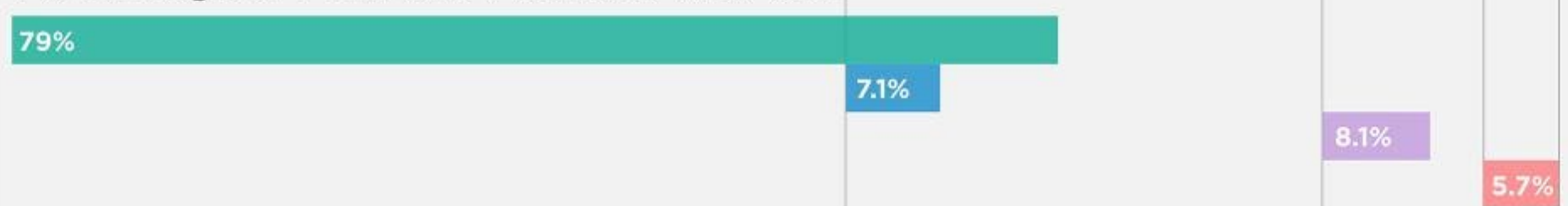

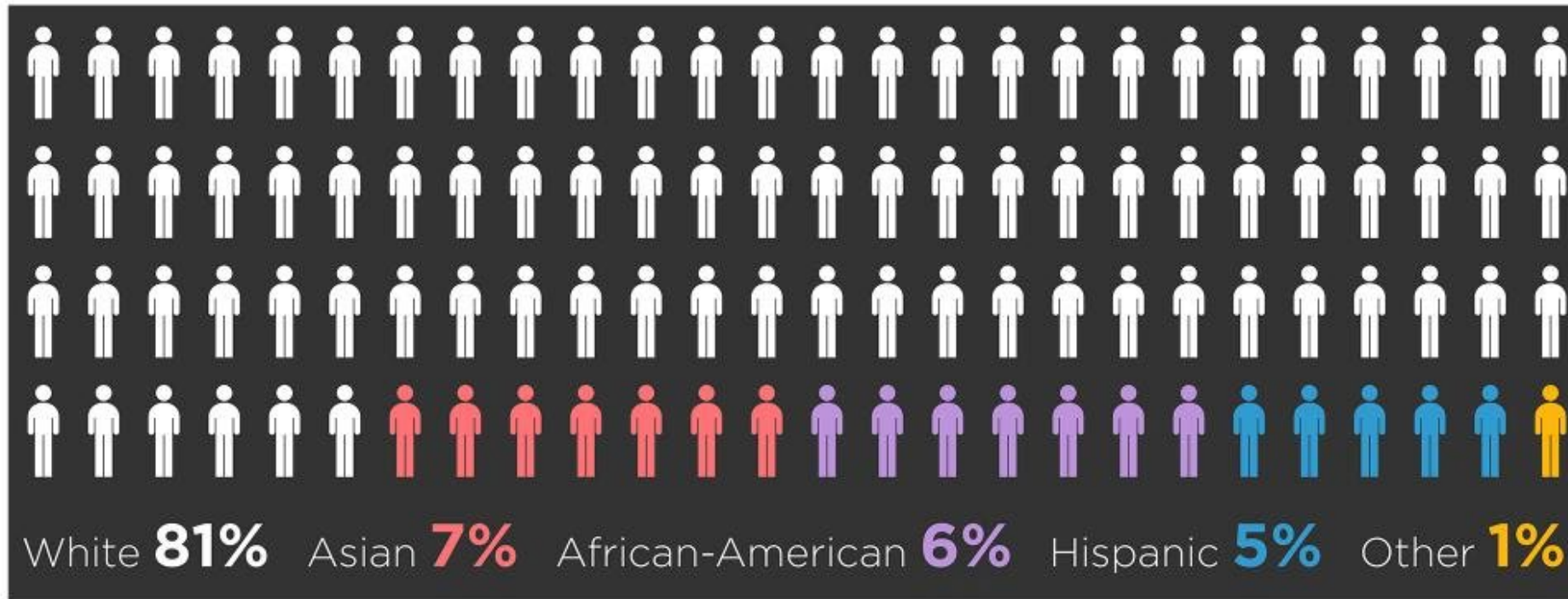
