**Medicare Accountable Care Policy & Addressing Perspectives about the ACO REACH Model**

**Elizabeth Fowler, Ph.D. JD**, is the Deputy Administrator and Director of the Center for Medicare and Medicaid Innovation (CMS Innovation Center). Dr. Fowler previously served as Executive Vice President of Programs at The Commonwealth Fund and Vice President for Global Health Policy at Johnson & Johnson. Dr. Fowler was special assistant to President Obama on health care and economic policy at the National Economic Council. In 2008-2010, she was Chief Health Counsel to Senate Finance Committee Chair, Senator Max Baucus (D-MT), where she played a critical role developing the Senate version of the Affordable Care Act. She also played a key role drafting the 2003 Medicare Prescription Drug, Improvement and Modernization Act (MMA). Dr. Fowler has over 25 years of experience in health policy and health services research. She earned her bachelor's degree from the University of Pennsylvania, a Ph.D. from the Johns Hopkins Bloomberg School of Public Health, where her research focused on risk adjustment, and a law degree (J.D.) from the University of Minnesota. She is admitted to the bar in Maryland, the District of Columbia, and the U.S. Supreme Court. Dr. Fowler is a Fellow of the inaugural class of the Aspen Health Innovators Fellowship and a member of the Aspen Global Leadership Network.

**Pauline Lapin MHS**, is the Director for the Seamless Care Models Group in the Center for Medicare and Medicaid Innovation at the Centers for Medicare & Medicaid Services. Ms. Lapin oversees innovative payment and delivery models related to accountable care organizations, kidney disease, Medicare Advantage and drugs. She holds a Master of Health Science degree from the Bloomberg School of Public Health.

**James G. Kahn MD MPH** is Emeritus Professor in the Philip R. Lee Institute for Health Policy Studies at the University of California, San Francisco. He has published widely on the cost and cost-effectiveness of prevention and treatment for HIV and other illnesses in the U.S. and in low and middle income countries. He has been funded by the U.S. National Institutes of Health, the Bill and Melinda Gates Foundation, and the World Health Organization, among other funders. He has more than 200 peer-reviewed articles and numerous book chapters. Dr. Kahn also studies and educates on the economics of U.S. insurance reform. Key research findings include: billing and insurance-related administration consumes nearly 25% of the costs of privately insured physician and hospital care (2005); potential savings reach \$400 billion per year via simplifying insurance-related administration (2014); and 21 of 22 economic studies of single payer project savings in the first year (2020). Dr. Kahn is a past President of the California

chapter of Physicians for a National Health Program. He is editor and chief blogger at Health Justice Monitor, a website and emailed newsletter.

**Alice Chen Ph.D.** is an Associate Professor of Public Policy & Vice Dean for Research at the USC Sol Price School of Public Policy. Her academic research focuses on improving the efficiency of health care markets. She examines how providers respond to changes in financial incentives and considers how health spending jointly affects health and labor indicators. Her work has been published in leading economics, policy, and medical journals, and has been cited in major media outlets, including Business Week, CBS News, Forbes, The Atlantic, and The Washington Post. At USC Price, Dr. Chen teaches health economics and health finance. Prior to earning her MBA and Ph.D. in business economics from the University of Chicago's Booth School of Business, Dr. Chen graduated with an AB and SM in applied math from Harvard University.
