I'm writing this letter to request a reconsideration of the decision regarding my industrial disability retirement. I agreed with this court that a benefit has the burden of proof to establish the right to claimed benefit the standard of proof of preponderance of the evidence.

I also agree that the Public employee pension legislation should be construed liberally in favor of the member. Construction cannot be permitted to eradicate the legislative purpose of the law be given to every employee public employees pensions legislation should be construed liberally in favor of the member.

The issues in my case that favor the member are:

- A. Respondent resigned under unfavorable
- B. Separation from employment in lieu of Disciplinary termination
- C. Eligibility qualification for industrial disability retirement

name Juvenile I retired because I had A major heart attack, I was told by my surgeon that saved my life that I could no longer work and that ended my career in law-enforcement period.

Secondly separation from employment due to unfavorable circumstances on or about May 14, 2010 I was flying out of town on personal business while passing through the security check I placed my belongings on the belt behind another passenger after collecting my things I saw a laptop thinking it was the gentleman is ahead of me I picked it up to return to him know that I had my own laptop with me and I knew how I would felt Had I left my own I tried to find the man I thought it belong to I stopped by the restroom before boarding and when I came out my flight was boarding shortly after boarding the plane Security approached and told me that I had to go with them to explain how I acquired the laptop which I complied with no problem they explained that this was misdemeanor but jurisdiction of this situation was out of their hands and they had to defer to San Mateo Police Department I was placed in custody and granted one phone call so I called my attorney I was then told by the correctional officer My employer had been notified of my arrest after two or three days I was released and return to work after reporting to work they placed me on administrative suspension for 30 days if you ever been arrested before they take everything from you cell phones and your money I've never stolen anything in my life on August 25, 2010 exhibit be my case was dismissed so that fact that I resigned in Lou of termination because of this case is ridiculous
