Subject: REGISTERED CALPERS LOBBYISTS QUARTERLY REPORT

The Political Reform Act prohibits certain CalPERS officials from receiving any gifts valued at over \$10 in a calendar month from certain registered lobbyists. Specifically, no "elected state officer" (which includes the six constituency-elected Board Members, and the State Controller and State Treasurer) may knowingly accept more than \$10 in gifts in a calendar month from any registered lobbyist.

Additionally, no "elected state officer or employee" (which includes all other Board Members, and CalPERS employees in classifications listed in CCR § 560) may knowingly accept more than \$10 in gift(s) in a calendar month from a person whose employer or firm lists CalPERS on its lobbyist registration statement (Government Code Sections 86201, 86203, and 86204).

Quarterly, staff reviews the registration statements of individuals who have appeared before the CalPERS Board and its committees to determine (a) if they are registered lobbyists, and if so, (b) whether their firm or employer lists CalPERS on its registration statement.

Following is a list of persons registered to lobby the CalPERS Board of Administration and/or who has appeared before the Board from March 2009 through March 2012.

Please be aware that while registration statements are required to be filed quarterly with the Secretary of State's Office, not all lobbyists or employers/firms may have maintained up-to-date registration statements.

PLEASE NOTE: The information provided in this database is based on filings with the Secretary of State's Office as of April 30, 2012. This list contains all persons registered to lobby the CalPERS Board of Administration, and all persons known to have lobbied the Board during March 2009 through March 2012.
