ITEM NAME: Proposed Decision – In the Matter of the Application for Earlier Date of Retirement of STACY A. ESAU, Respondent, and DEPARTMENT OF CORRECTIONS AND REHABILITATION, DEUEL VOCATIONAL INSTITUTION, Respondent.

PROGRAM: Benefit Services Division

PARTIES' POSITIONS

Staff argues that the Board of Administration should adopt the Proposed Decision, as modified.

Respondent argues that the Board of Administration should decline to adopt the Proposed Decision.

PROCEDURAL SUMMARY

Respondent Stacy A. Esau submitted an application for earlier date of retirement. CalPERS denied the application for earlier date of retirement. Respondent appealed this decision and the matter was heard by the Office of Administrative Hearings on October 19, 2012. A Proposed Decision was issued on May 17, 2013, denying the application for earlier date of retirement.

ALTERNATIVES

- A. For use if the Board decides to adopt the Proposed Decision, as modified, as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby modifies the Proposed Decision as follows:

1. Replacing the name "CalPERS" in paragraph 13, line 8, page 9, with the name "CDCR",

and adopts as its own Decision the Proposed Decision dated May 17, 2013, as modified, concerning the application for earlier date of retirement of Stacy A. Esau; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

- B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated May 17, 2013, concerning the application for earlier date of retirement of Stacy A. Esau, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

- C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated May 17, 2013, concerning the application for earlier date of retirement of Stacy A. Esau, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

- D. Precedential Nature of Decision (two alternatives; either may be used):

1. For use if the Board wants further argument on the issue of whether to designate its Decision as precedential:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the application for earlier date of retirement of Stacy A. Esau, as well as interested parties, to submit written argument regarding whether the Board's Decision in this matter should be designated as precedential, and that the Board will consider the issue whether to designate its Decision as precedential at a time to be determined.

2. For use if the Board decides to designate its Decision as precedential, without further argument from the parties.

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, hereby designates as precedential its Decision concerning the earlier date of retirement application of Stacy A. Esau.
