Section 20361 of the Retirement Law provides that the following employees shall not become members of the Retirement System unless an election in writing is filed with the Board:

"Section 20361. An elective officer is excluded from membership in this system unless he files with the board an election in writing to become a member. He may so elect at any time, and has the option of making contributions to this system in the amount which he would have contributed had he not been so excluded. If he affirmatively exercises the option:

- (a) He shall receive credit for prior service in the same manner as if he had not been excluded, and
- (b) The contributions of the State or contracting agency because of his membership, shall be the same as they would have been had he not been excluded, and
- (c) His rate of contributions shall be based on the nearest age at the time he first was excluded.

As used in this part, 'elective officer' includes any officer of the Senate or Assembly who is elected by vote of the members of either or both of such houses of the Legislature, and any appointive officer of a city or county occupying a fixed term of office, and any person holding the office of city attorney, as well as officers of the state or contracting agencies elected by the people."

I am an elective officer, being the COUNCILMAN of CITY OF CUDAHY (Title) My present term will expire on MARCH 7th, 1978. In accordance with the provisions of the Retirement Law, I therefore, elect to become a member of the Retirement System, and I request that this notice be filed by the Board of Administration of the Public Employees' Retirement System as my election to become such a member.

I understand that a form upon which I may take action under the option of making contributions as provided in Section 20361 will be furnished with a statement of the amount of such contributions.
