Staff argues that the Board of Administration should adopt the Proposed Decision.

Respondent argues that the Board of Administration should decline to adopt the Proposed Decision.

PROCEDURAL SUMMARY

Respondent Joseph P. Furman submitted a "Request for Service Credit Cost Information-Additional Retirement Service Credit (Additional Retirement Service Credit)" on January 29, 2004. CalPERS sent the cost and election packet to Mr. Furman on August 19, 2004. Approximately seven years later, in late 2010, Respondent requested to proceed with the purchase of service credit. CalPERS denied the request because Respondent was no longer employed by a CalPERS agency. Respondent appealed this decision and the matter was heard by the Office of Administrative Hearings on September 9, 2014. A Proposed Decision was issued on October 20, 2014, denying the request because Respondent was no longer an active member of CalPERS, as required by Government Code section 20909.

ALTERNATIVES

A. For use if the Board decides to adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated October 20, 2014, concerning the request to

purchase Additional Retirement Service Credit by Joseph P. Furman; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated October 20, 2014, concerning the request to purchase Additional Retirement Service Credit by Joseph P. Furman, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated October 20, 2014, concerning the request to purchase Additional Retirement Service Credit by Joseph P. Furman, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

 - 1. For use if the Board wants further argument on the issue of whether to designate its Decision as precedential:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the request to purchase Additional Retirement Service Credit by Joseph P. Furman, as well as interested parties, to submit written argument regarding whether the Board's Decision in this matter should be designated as precedential, and that the Board will consider the issue whether to designate its Decision as precedential at a time to be determined.
