AGENDA ITEM 5a – INDEPENDENT OVERSIGHT, Contracts Administration: General Pension Investment Board Consulting Services – Selection of Finalists for Interview

Wylie Tollette, Chief Operating Investment Officer, presented the item. The presentation outlined the candidate firms available for interview as part of the General Pension Investment Board Consulting Services Request for Proposal process. The two firms available for interview were Meketa Investment Group, Inc. and Wilshire Associates Incorporated. It was noted that an updated scoring table, reflecting a corrected total score for Wilshire Associates Incorporated had been distributed.

The Committee discussed concerns regarding the relatively low number of bidders for this contract.

On **MOTION** by Mr. Jelincic, **SECONDED** and **CARRIED**, to interview both Meketa Investment Group Inc. and Wilshire Associates Incorporated for the General Pension Investment Board Consultant. Mr. Costigan, Mr. Slaton, and Ms. Hollinger voted "no." The motion passed.

Anne Simpson, Senior Portfolio Manager, presented the item. The presentation included an overview of the methodology utilized by staff to evaluate companies which may be subject to the provisions of the California Public Divest from Iran Act and staffs' recommendation to approve two companies as not subject to the provisions of the Iran Act.

Tom McDonagh, Acting Senior Investment Officer, presented the item. The presentation included an overview of the Real Assets Program's characteristics, performance, structure, and key accomplishments. The integration of the Investment Beliefs into the Program was also discussed.
