**ITEM NAME:** Proposed Decision – In the Matter of the Application for Industrial Disability Retirement of ANDREW WARREN, Respondent, and CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION, RJ DONOVAN CORRECTIONAL FACILITY, Respondent.

#### PROCEDURAL SUMMARY

Respondent Warren submitted an application for Industrial Disability Retirement (IDR), based on psychological conditions (depression/post-traumatic stress disorder). CalPERS denied the application. Respondent appealed this decision and the matter was heard by the Office of Administrative Hearings on December 4, 2014. A Proposed Decision was issued on January 2, 2015, denying the application.

#### **ALTERNATIVES**

A. For use if the Board decides to adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the

Proposed Decision dated January 2, 2015, concerning the appeal of Andrew L. Warren; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated January 2, 2015, concerning the appeal of Andrew L. Warren, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated January 2, 2015, concerning the appeal of Andrew L. Warren, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

  - 1. For use if the Board wants further argument on the issue of whether to designate its Decision as precedential:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the appeal of Andrew L.
