ITEM NAME: Proposed Decision – In the Matter of the Appeal of EDWARD MOORE for the Denial of Reimbursement for Direct Voice Rehabilitation.

PROGRAM: Health Plan Administration Division

PARTIES' POSITIONS

Staff argues that the Board of Administration should adopt the Proposed Decision.

Respondent Edward Moore (Respondent Moore) argues that the Board of Administration should decline to adopt the Proposed Decision.

STRATEGIC PLAN

This item is not a specific product of either the Strategic or Annual Plans. The determination of administrative appeals is a power reserved to the Board of Administration.

PROCEDURAL SUMMARY

Respondent Moore submitted a request for reimbursement for Direct Voice Rehabilitation to AllCare, the agent of Blue Shield of California. AllCare denied the request. Respondent Moore appealed to Blue Shield of California. Blue Shield of California upheld the denial. Respondent Moore appealed to Department of Managed Healthcare (DMHC). DMHC upheld the denial. Respondent Moore appealed to CalPERS. CalPERS upheld the denial. Respondent Moore appealed this determination and the matter was heard by the Office of Administrative Hearings on February 17 and 20, 2015. A Proposed Decision was issued on March 12, 2015, denying the appeal.

ALTERNATIVES

A. For use if the Board decides to adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Agenda Item 8a Board of Administration May 20, 2015 Page 2 of 3

Proposed Decision dated March 12, 2015, concerning the appeal of Edward Moore; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated March 12, 2015, concerning the appeal of Edward Moore, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated March 12, 2015, concerning the appeal of Edward Moore, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

 - 1. For use if the Board wants further argument on the issue of whether to designate its Decision as precedential:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the appeal of Edward Moore, as well as interested parties, to submit written argument regarding whether the Board's Decision in this matter should be designated as precedential, and that the Board will consider the issue whether to designate its Decision as precedential at a time to be determined.
