AGENDA ITEM 5 – 2015-16 FEDERAL HEALTH CARE POLICY AGENDA

Danny Brown, Chief, Legislative Affairs Division, with Yvette Fontenot and Chris Jennings, presented the proposed CalPERS 2015-16 Federal Health Care Policy Priorities. The recommended priorities for 2015-16 are: Prescription Drug Management & Cost Containment; Delivery System Reform; Tax Policy (Excise Tax); and, Transparency.
