PROCEDURAL SUMMARY

Respondent Soto submitted an application for disability retirement based on orthopedic conditions (bilateral shoulder and bilateral thumb). CalPERS approved the application for disability retirement. After review of medical reports, CalPERS determined that Respondent Soto is no longer incapacitated from his duties as a Program Technician I. Respondent Soto appealed this decision and the matter was heard by the Office of Administrative Hearings on June 1, 2015 and June 3, 2015. A Proposed Decision was issued on June 22, 2015, granting Respondent Soto's appeal.

ALTERNATIVES

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated June 22, 2015, concerning the appeal of Daniel M. Soto; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated June 22, 2015, concerning the appeal of Daniel M. Soto, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated June 22, 2015, concerning the appeal of Daniel M. Soto, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.
