

RESOLUTION NO. 5226

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VERNON AMENDING SCHEDULE VII, EXHIBIT "F", OF RESOLUTION NO. 5197, WHICH AMENDED RESOLUTION NO. 4918 FIXING THE COMPENSATION FOR CERTAIN EMPLOYEES OF SAID CITY AND AUTHORIZING CERTAIN EXPENSE ALLOWANCES

WHEREAS, Resolution No. 5197 was adopted by the City Council of the City of Vernon on June 27, 1985, to be effective on July 1, 1985; and

WHEREAS, Resolution No. 5197 was previously amended by Resolution No. 5213, adopted by the City Council of the City of Vernon on September 24, 1985; and

WHEREAS, Schedule VII, Exhibit "F", of Resolution No. 5197 provides for the position and salary scale of City Administrator/City Clerk in the City Administrator/City Clerk Department; and

WHEREAS, the City Council of the City of Vernon has considered the performance of the City Administrator/City Clerk on his annual review date for the purposes of considering a merit increase; and

WHEREAS, the City Council of the City of Vernon intends to establish a new salary scale to provide for a merit increase for the position of City Administrator/City Clerk in the City Administrator/City Clerk Department and to provide for additional executive leave days as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VERNON AS FOLLOWS:

SECTION 1: That the City Council of the City of Vernon does hereby find and determine that the recitals contained

1 hereinabove are true and correct.

2 SECTION 2: That effective October 27, 1985, Schedule  
3 VII, Exhibit "F", of Resolution No. 5197, shall be amended as  
4 follows:

5 (1) Page F-1 shall be amended to establish the  
6 following salary scale for the position of City Administrator/  
7 City Clerk:

8 City Administrator/  
9 City Clerk \$ 8,733.00 per month

10 (2) Page F-4, lines 17 and 18, shall be amended to  
11 read as follows:

12 (d) Ten (10) days of executive leave to be used  
13 prior to June 30, 1986;

14 SECTION 3: That in all other respects, Resolution No.  
15 5197, as amended by Resolution No. 5213, shall remain in full  
16 force and effect and that the provisions in Resolution Nos.  
17 5197 and 5213 not consistent with or in conflict with this  
18 Resolution are hereby repealed.

19 SECTION 4: The City Clerk of the City of Vernon is  
20 hereby directed to certify to the passage of this Resolution  
21 and thereupon and thereafter the same shall be in full force and  
22 effect.
