

**RESOLUTION NO. 5564**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VERNON AMENDING SECTION 21, SUBSECTION (e), OF RESOLUTION NO. 5531 WHICH FIXED THE COMPENSATION FOR CERTAIN EMPLOYEES OF SAID CITY AND AUTHORIZED CERTAIN EXPENSE ALLOWANCES

WHEREAS, Resolution No. 5531 was adopted by the City Council of the City of Vernon on June 30, 1988, to be effective on July 1, 1988; and

WHEREAS, Resolution No. 5546 was adopted by the City Council of the City of Vernon on August 23, 1988, amending Resolution No. 5531; and

WHEREAS, the City Council of the City of Vernon has considered the performance of the City Administrator/City Clerk on his annual review date for the purposes of considering a merit increase; and

WHEREAS, the City Council of the City of Vernon intends to establish a new salary scale to provide for a merit increase for the position of City Administrator/City Clerk in the City Administrator/City Clerk Department and to provide for additional benefits as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VERNON AS FOLLOWS:

**SECTION 1:** That the City Council of the City of Vernon does hereby find and determine that the recitals contained hereinabove are true and correct.

**SECTION 2:** That effective October 24, 1988, Exhibit "A", Schedule II, page 15 of Resolution No. 5531 shall be amended to establish the following salary scale for the posi-

1 tion of City Administrator/City Clerk:

2 City Administrator/City

3 Clerk-4000

Step 1

\$14,213 per month

4 SECTION 3: That effective October 24, 1988, Section  
5 21, subsection (e) of Resolution No. 5531 shall be amended to  
6 read as follows:

7 (e) In addition to the salary provided for in  
8 Schedule II, Exhibit "A", and the benefits provided for  
9 herein, the City Administrator/City Clerk shall be provided  
10 the following:

11 (1) Life insurance equal to the sum of  
12 \$310,000.00;

13 (2) One hundred percent (100%) of all medical  
14 and dental expenses to be paid by the City  
15 after insurance has paid;

16 (3) Reimbursement for all expenses incurred for  
17 employee activities such as sports leagues  
18 (softball, basketball, etc.);

19 (4) Twelve (12) days of executive leave to be  
20 used prior to June 30, 1989;

21 (5) The City shall make a direct payment of  
22 \$7,500.00 to the ICMA Retirement Corporation  
23 on an annual basis on January 1 of each year  
24 as deferred compensation, all of said  
25 amounts shall be credited to his individual  
26 account;

27 (6) An expense allowance of \$1,000.00 per month;

28 (7) The City, who opened an IRA account and

1 deposited the sum of \$2,000.00 effective  
2 January 1, 1986, and said \$2,000.00 shall be  
3 deposited each and every year thereafter on  
4 or about January 1.

5 (8) Any unused vacation and/or executive leave  
6 days off can be carried over from year-to-  
7 year for a maximum of two (2) years. In the  
8 event that said accumulated vacation and/or  
9 executive leave time is not used in the two-  
10 year accumulation period, then the City  
11 shall pay him for any such time not used;

12 (9) The City shall purchase a membership in the  
13 California Country Club for him;

14 (10) The City shall pick up his portion of the  
15 automobile insurance;

16 (11) The City shall allow him the use of Deloitte  
17 Haskins & Sells for tax advisement reasons,  
18 at no cost to the City; and

19 (12) Continued use of limousine service for per-  
20 sonal use, not to exceed 20 trips.

21 (13) The hours of work to be as necessary.

22 SECTION 4: That in all other respects, Resolution  
23 No. 5531, as amended by Resolution Nos. 5546 and 5555, shall  
24 remain in full force and effect and the provisions in Resolu-  
25 tion Nos. 5531, 5546, and 5555 not consistent with or in con-  
26 flict with this resolution are hereby repealed.

27 SECTION 5: The City Clerk of the City of Vernon is  
28 hereby directed to certify to the passage of this resolution

1 and thereupon and thereafter the same shall be in full force  
2 and effect.
