WHEREAS, the City Council of the City of Vernon intends to establish a new salary scale to provide for a merit increase for the position of City Administrator/City Clerk in the City Administrator/City Clerk Department and to provide for additional benefits as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VERNON AS FOLLOWS:

SECTION 1: The City Council of the City of Vernon does hereby find and determine that the recitals contained hereinabove

are true and correct.

SECTION 2: Effective October 15, 1995, Section 25, subsections (e)(7), of Resolution No. 6651 is amended to read as follows:

twenty-five (25) years of consecutive uninterrupted service after October 15, 1995, to receive an additional twenty-five percent (25%) of his base salary per month upon reaching his 25th anniversary date and shall be entitled to said twenty-five percent (25%) per month upon said anniversary date and every year thereafter.

## Compensation Not Cumulative. (h)

Payment of the aforesaid longevity compensation shall not be cumulative and only the highest applicable longevity pay shall be paid.

SECTION 6: In all other respects, Resolution No. 6651, as amended by Resolution Nos. 6670, 6671, and 6696, shall remain in full force and effect, and the provisions of Resolution Nos. 6651, 6670, 6671, and 6696 not consistent with or in conflict with this resolution are hereby repealed.

SECTION 7: The City Clerk of the City of Vernon shall certify to the passage of this resolution and thereupon and thereafter the same shall be in full force and effect.
