

RESOLUTION NO. 7534

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
VERNON AMENDING RESOLUTION NO. 7359 BY AMENDING
PAGE 12 OF SCHEDULE II, EXHIBIT "B" OF SAID
RESOLUTION WHICH FIXED THE COMPENSATION FOR CERTAIN
EMPLOYEES OF SAID CITY AND AUTHORIZED CERTAIN
EXPENSE ALLOWANCES

WHEREAS, Resolution No. 7359 was adopted by the City Council
of the City of Vernon on June 29, 1999, to be effective on July 1,
1999; and

WHEREAS, the City Council of the City of Vernon adopted
Resolution No. 7458 on December 21, 1999, which modified certain
benefits of the City Administrator/City Clerk effective November 21,
1999; and

WHEREAS, a new salary scale to provide for modified benefits
for the position of City Administrator/City Clerk in the City
Administrator/City Clerk Department was inadvertently omitted from
Resolution No. 7458; and

WHEREAS, Schedule II, Exhibit "B", page 12 of Resolution No.
7359 needs to be modified in order to be in compliance with the
modifications approved for the position and salary scale of the City
Administrator/City Clerk in the City Administrator/City Clerk
Department effective November 21, 1999.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE
CITY OF VERNON AS FOLLOWS:

SECTION 1: The City Council of the City of Vernon hereby
finds and determines that the recitals contained hereinabove are true
and correct.


1 SECTION 2: Effective November 21, 1999, Schedule II,

5 Department as indicated on the amended page 12 of Schedule II, Exhibit
6 "B", which is attached hereto as Attachment A and made a part hereof.

7 SECTION 3: The provisions of Resolution Nos. 7359, 7400,
8 7416, 7425, 7445 and 7458 not consistent with or in conflict with this
9 resolution are hereby repealed; in all other respects, Resolution No.
10 7359, as amended by Resolution Nos. 7400, 7416, 7425, 7445, 7458 and
11 7534 shall remain in full force and effect.

12 SECTION 4: The City Clerk of the City of Vernon shall
13 certify to the passage of this resolution, and thereupon and thereafter
14 the same shall be in full force and effect.
