Regarding Gas Distribution System, was presented.

The Facilities Study will determine the transmission system upgrades and any equipment modification or additions required. The cost for these services is approximately \$55,000.00. This has been reviewed by the Director of Utilities and the City Attorney and it is hereby recommended that said agreement be approved and executed.

The City Attorney recommended to the Council that they consider entering into an agreement with the Law Offices of David Brearley for consulting services that will include matters pertaining to Utilities.


