PROCEDURAL SUMMARY

CalPERS made a determination to accept the 2010 will and supersede the 1997 beneficiary designation. Respondent Phillip appealed this determination. The matter was heard by the Office of Administrative Hearings on September 28, 2015. A Proposed Decision was issued on September 29, 2015, denying the appeal.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated September 29, 2015, concerning the appeal of Phillip Garrido, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated September 29, 2015, concerning the appeal of Phillip Garrido, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.
