- 1. True and correct copies of all documents of any kind in CaIPERS' possession or under its control referring or relating to or bearing on Mr. Lewis, including those related to or bearing on pension rights and benefits;
- 2. True and correct copies of all documents of any kind in CalPERS' possession or under its control referring or relating to or bearing on CalPERS' review(s) of the San Bernardino Fire Department ("SBFD") and/or the City of San Bernardino ("City"), including an audit wherein CalPERS made a determination that it would cut the pension benefits of Mr. Lewis;
- 3. True and correct copies of all documents in CalPERS' possession or under its control referring or relating to or bearing on any communications between the City and/or SBFD and CalPERS at any point from January 1, 2007 to the present, including those concerning Mr. Lewis' pension rights and benefits, including but not limited to communications concerning the City's and/or SBFD's agreement to pay him the base salary of Battalion Chief and how this would be treated for pension calculation purposes;
- 4. True and correct copies of all documents in CalPERS' possession or under its control related to any and all CalPERS reviews or analyses or calculations of the pension benefits to which it believes Mr. Lewis is entitled;

True and correct copies of all documents in CalPERS' possession or under its control referring or relating to or bearing on any communications between the City and/or SBFD and CalPERS concerning Mr. Lewis' claims against the City and/or the SBFD resulting from the SMFD's failure to promote him to the position of Battalion Chief in or about 2003;
- 6. True and correct copies of all documents in CalPERS' possession or under its control referring or relating to or bearing on the settlement between the City and/or the SBFD and Mr. Lewis in or about 2007 concerning his claims resulting
