
#### **PRESENTATIONS**

Lawrence Reinhold commented on Item 9 and expressed his disapproval of the proposed community information monument sign.


AM/Lim made a motion to close Oral Communications; seconded by AM/Cartagena. Motion carried without objection and so ordered.



Walnut City Council meeting called to order.
