ITEM NAME: Proposed Decision – In the Matter of the Accusation Seeking Reinstatement from Industrial Disability Retirement of VINCENT C. MILLER, Respondent, and CALIFORNIA CORRECTIONAL CENTER, SUSANVILLE, CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION, Respondent.

PARTIES' POSITIONS

Staff argues that the Board of Administration should adopt the Proposed Decision.

Respondent Vincent C. Miller (Respondent Miller) argues that the Board of Administration should decline to adopt the Proposed Decision.

STRATEGIC PLAN

This item is not a specific product of either the Strategic or Annual Plans. The determination of administrative appeals is a power reserved to the Board of Administration.

PROCEDURAL SUMMARY

Respondent Miller submitted an application for Industrial Disability Retirement based on psychological (major depressive disorder, personality disorder) conditions. CaIPERS approved the application for Industrial Disability Retirement and Respondent Miller retired effective November 1, 2009. In August 2013, after review of medical reports, CaIPERS determined that Respondent Miller was no longer incapacitated from his duties as a Correctional Officer. Respondent Miller appealed this decision and the matter was heard by the Office of Administrative Hearings on December 1, 2015. A Proposed Decision was issued on December 29, 2015, denying Respondent Miller's appeal.

> RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated December 29, 2015, concerning the appeal of Vincent C. Miller; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 29, 2015, concerning the appeal of Vincent C. Miller, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 29, 2015, concerning the appeal of Vincent C. Miller, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the appeal of Vincent C.
