PROCEDURAL SUMMARY

Respondent Juarez submitted an application for Industrial Disability Retirement based on a pulled rib muscle on the left side of the back. CalPERS denied the application for Industrial Disability Retirement. Respondent Juarez appealed this determination and the matter was heard by the Office of Administrative Hearings on December 16, 2015. A Proposed Decision was issued on December 30, 2015, denying the application for Industrial Disability Retirement.

ALTERNATIVES

A. For use if the Board decides to adopt the Proposed Decision, as modified, as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, pursuant to Government Code section 11517(c)(2)(C), which authorizes the Board to "make technical or other minor changes in the proposed decision", hereby modifies the Proposed Decision, by inserting the word "industrial" before the words "disability retirement" in the case caption and in the "Order" section of the Proposed Decision, and hereby adopts as its own Decision the Proposed Decision dated December 30, 2015, as modified, concerning the application of Salma O. Juarez; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides to adopt the Proposed Decision, as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated December 30, 2015, concerning the application of Salma O. Juarez; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

C. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 30, 2015, concerning the application of Salma O. Juarez, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

D. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 30, 2015, concerning the application of Salma O. Juarez, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.
