PARTIES' POSITIONS

Staff argues that the Board of Administration should adopt the Proposed Decision.

Respondent Timothy C. Stadler (Respondent Stadler) argues that the Board of Administration should decline to adopt the Proposed Decision.

Respondent Rodger D. Ciano (Respondent Ciano) argues that the Board of Administration should adopt the Proposed Decision.

PROCEDURAL SUMMARY

Respondent Stadler submitted an application for Death Benefits upon the death of Larri K. Ciano (Decedent). CalPERS rejected the application. Respondent Stadler appealed this determination and the matter was heard by the Office of Administrative Hearings on November 23, 2015. A Proposed Decision was issued on December 10, 2015, denying the appeal because Respondent Stadler did not established that the Decedent intended to designate the Larrie K. Ciano Family Trust as her primary beneficiary.

ALTERNATIVES

A. For use if the Board decides to adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated December 10, 2015, concerning the appeal of Timothy C. Stadler; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 10, 2015, concerning the appeal of Timothy C. Stadler, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 10, 2015, concerning the appeal of Timothy C. Stadler, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

 - 1. For use if the Board wants further argument on the issue of whether to designate its Decision as precedential:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the appeal of Timothy C.
