ITEM NAME: Proposed Decision – In the Matter of the Final Compensation Benefit Calculation of NICHOLAS G. RODRIGUEZ, Respondent; CITY OF VERNON,

Respondent; and CITY OF PASADENA, Respondent.

PARTIES' POSITIONS

Staff argues that the Board of Administration should adopt the Proposed Decision.

Respondent Nicholas G. Rodriguez (Respondent Rodriguez) argues that the Board of Administration should decline to adopt the Proposed Decision.

STRATEGIC PLAN

This item is not a specific product of either the Strategic or Annual Plans. The determination of administrative appeals is a power reserved to the Board of Administration.

PROCEDURAL SUMMARY

Respondent Rodriguez filed a Service Retirement Election Application and has been receiving a retirement allowance since December 6, 2013. At retirement, Respondent Rodriguez had a total of 29.651 years of service credit with Respondent City of Pasadena and 1.313 years of service credit with Respondent City of Vernon. Respondent Rodriguez requested that CalPERS apply his highest one-year final compensation, a benefit that Respondent Vernon contracts for, to his Pasadena service credit. Pasadena contracts for a three-year final compensation. CalPERS denied this request. Respondent Rodriguez appealed this determination and the matter was heard by the Office of Administrative Hearings on September 2, 2015. A Proposed Decision was issued on December 11, 2015, denying the appeal.

ALTERNATIVES

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated December 11, 2015, concerning the appeal of Nicholas G. Rodriguez; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 11, 2015, concerning the appeal of Nicholas G. Rodriguez, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 11, 2015, concerning the appeal of Nicholas G. Rodriguez, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.
