ITEM NAME: Proposed Decision – In the Matter of the Appeal for Reciprocity in the Calculation of Final Compensation of GERE SIBBACH, Respondent, CITY OF MORRO BAY, Respondent and SAN LUIS OBISPO COUNTY, Respondent.

PARTIES' POSITIONS

Staff argues that the Board of Administration should adopt the Proposed Decision.

Respondent Gere Sibbach (Respondent Sibbach) argues that the Board of Administration should decline to adopt the Proposed Decision.

STRATEGIC PLAN

This item is not a specific product of either the Strategic or Annual Plans. The determination of administrative appeals is a power reserved to the Board of Administration.

PROCEDURAL SUMMARY

Respondent Sibbach submitted applications for service retirement with CalPERS and from San Luis Obispo County Pension Trust (SLOCPT) concurrently and requested that CalPERS grant final compensation reciprocity. CalPERS denied the request for final compensation reciprocity. Respondent Sibbach appealed this determination and the matter was heard by the Office of Administrative Hearings on November 30, 2015. A Proposed Decision was issued on December 23, 2015, finding that Respondent Sibbach is not entitled to final compensation reciprocity.

ALTERNATIVES

A. For use if the Board decides to adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated December 23, 2015, concerning the appeal of Gere Sibbach; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 23, 2015, concerning the appeal of Gere Sibbach, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

C. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated December 23, 2015, concerning the appeal of Gere Sibbach, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

 - 1. For use if the Board wants further argument on the issue of whether to designate its Decision as precedential:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the appeal of Gere Sibbach, as well as interested parties, to submit written argument regarding whether the Board's Decision in this matter should be designated as precedential, and that the Board will consider the issue whether to designate its Decision as precedential at a time to be determined.

2. For use if the Board decides to designate its Decision as precedential, without further argument from the parties.

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, hereby designates as precedential its Decision concerning the appeal of Gere Sibbach.
