The JRF II provides retirement benefits to judges elected on or after November 9, 1994. This fund is invested in a moderately aggressive asset allocation strategy.





SIP Overview

The SIP is comprised of the Public Employees' Deferred Compensation Fund (457 Plan) and the Supplemental Contributions Program Fund (SCP). As of March 16, 2015, the State Peace Officers' and Firefighters' Defined Contribution Plan Fund (POFF) accounts have been closed. The 457 Plan is a pretax defined contribution plan for public agency and school employees. The SCP is an after-tax program available to State employees, school employees, and contracting agencies.
