
PUBLIC EMPLOYEES' HEALTH CARE FUND (HCF)

As of March 16, 2015, the State Peace Officers' and Firefighters' Defined Contribution Plan Fund (POFF) accounts have been closed. The 457 Plan is a pretax defined contribution plan for public agency and school employers. The SCP is an after-tax program available to State employees, school employees, and contracting agencies.
