This Order shall be marked as exhibit 31.

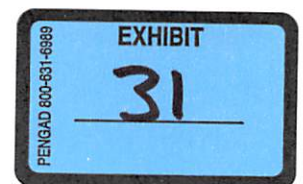
The record in this matter was closed, and the case was submitted for decision, upon receipt of the last briefs on August 8, 2016.
