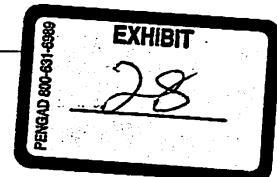

23 Government Code section 11508(c) provides that, if a party objects to the place of hearing,
24 that party must make a motion to the administrative law judge within 10 days after this notice is
25 served on the party. Failure to notify the administrative law judge within 10 days will deprive a
26 party of a change in the place of the hearing. Pursuant to Government Code section 20134, however,
27 for appeals to the CalPERS Board of Administration, such as this appeal, "[s]ection 11508 shall not
28 apply, and the hearing shall be held at the time and place determined by the board." Board

5 your own expense. You are not entitled to the appointment of an attorney to represent you at public
6 expense. You are also entitled to represent yourself without legal counsel. You may present any
7 relevant evidence, and will be given full opportunity to cross-examine all witnesses testifying against
8 you. You are entitled to the issuance of subpoenas to compel the attendance of witnesses and the
9 production of books, documents or other things by applying to the Los Angeles Office of
10 Administrative Hearings.
