19 met and conferred to discuss foundational issues and stipulations. No stipulations were reached.

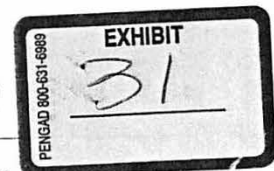
20 2. The JRS objects to Mast's untimely motion in limine, which was supposed to be filed


