19 To the above-named Respondent: You are hereby notified that the hearing in this remanded  
20 matter will be held before the Office of Administrative Hearings, at 320 W. Fourth Street, Suite 630,  
21 Los Angeles, CA 90013. The hearing will begin at 1:30 p.m. on August 19, 2016.

22 Government Code section 11508(c) provides that, if a party objects to the place of hearing,  
23 that party must make a motion to the administrative law judge within 10 days after this notice is  
24 served on the party. Failure to notify the administrative law judge within 10 days will deprive a  
25 party of a change in the place of the hearing. Pursuant to Government Code section 20134, however,  
26 for appeals to the CalPERS Board of Administration, such as this appeal, "[s]ection 11508 shall not  
27 apply, and the hearing shall be held at the time and place determined by the board." Board  
28 Regulation 555 delegates the Board of Administration's authority regarding the hearings process to

1 the CalPERS Executive Officer and his/her subordinates. In this case, CalPERS has determined that  
2 the Los Angeles OAH is the most appropriate forum for this hearing.

3 You may be present at the hearing. You have the right to be represented by an attorney at  
4 your own expense. You are not entitled to the appointment of an attorney to represent you at public  
5 expense. You are also entitled to represent yourself without legal counsel. You may present any  
6 relevant evidence, and will be given full opportunity to cross-examine all witnesses testifying against  
7 you. You are entitled to the issuance of subpoenas to compel the attendance of witnesses and the  
8 production of books, documents or other things by applying to the Los Angeles Office of  
9 Administrative Hearings.


