**DECLARATION OF PAMELA
MONTGOMERY**

18 I, Pamela Montgomery, declare as follows:

19 1. I began working for the California Public Employees' Retirement System
20 ("CalPERS") in November 1974. From March 2005 through November 2011, I was a CalPERS
21 Staff Services Manager II, responsible for the administration of the Judges' Retirement System
22 ("JRS"). I retired from my full time position with the JRS on November 2, 2011, and since February
23 2012, I have been working part time for the JRS. I make this declaration based on my own personal
24 knowledge of the facts stated in this declaration.

25 2. As a result of my employment experiences with the JRS, I am familiar with the
26 operations and record-keeping practices of the JRS.

27 3. The JRS has records that show all payments that the JRS has made to Respondent
28 Paul G. Mast ("Mast") since April 6, 2009. True and correct copies of those records are attached

1 hereto as Exhibit A.

2 4. Government Code section 75033.5 requires that Mast's allowance must be equal to
3 49.4572% of the compensation payable to the judge holding the office which Mast last held prior to
4 his discontinuance of his service as judge. That 49.4572% figure is the product of 3.75% times
5 Mast's years of judicial service (approximately 13.2 years).

6 5. Using the records attached hereto as Exhibit A, I created a spreadsheet that compares
7 how much Mast received from the JRS, since April 6, 2009, with how much Mast would have
8 received from the JRS if his retirement allowance had been calculated in compliance with
9 Government Code section 75033.5, since April 6, 2009. I also calculated 7% simple interest on all
10 overpayments that the JRS made to Mast since April 6, 2009, with interest running through August
11 31, 2016. That spreadsheet is attached hereto as Exhibit B.

12 6. Using the records attached hereto as Exhibit A, I created a spreadsheet that compares
13 how much Mast received from the JRS, since December 29, 2011, with how much Mast would have
14 received from the JRS if his retirement allowance had been calculated in compliance with
15 Government Code section 75033.5, since December 29, 2011. I also calculated 7% simple interest
16 on all overpayments that the JRS made to Mast since December 29, 2011, with interest running
17 through August 31, 2016. That spreadsheet is attached hereto as Exhibit C.

18 I declare, under penalty of perjury, under the laws of the State of California, that the
19 foregoing is true and correct and that this declaration was executed in Sacramento, California, on
20 June 8, 2016.
