

The Extended Risk Segment represented 15% of the Infrastructure Program.	The Policy states that Risk Segments only apply when the NAV of the Infrastructure Portfolio exceeds \$3.0 billion early stage threshold. Q2 2016 was the first quarter since program inception that the NAV exceeded the \$3.0 billion threshold triggering the reportable event. While the IC approved recent changes to the Policy at the August 2016 meeting, the existing policy (dated February 16, 2016) remains in effect until Wilshire, StepStone and PCA agree on the content of the Investment Policy Procedures & Guidelines (IPPGs). Once agreement is reached, this exception is expected to be resolved.
