### Agenda Item 5 – Long-Term Care Program Semi-Annual Report

As an information item, Kathy Donneson, Chief, Health Plan Administration Division, and CJ Nakayama, CalPERS team member, presented an update on the CalPERS Long-Term Care (LTC) Program. The LTC Program overview compared the calendar years 2014, 2015 and 2016. The trends provided comparative information related to program performance and sustainability efforts.
