In December 2017, the Finance & Administration Committee (Committee) recommended that the California Public Employees' Retirement System (CalPERS) Board of Administration (Board) approve a proposed Fiscal Year (FY) 2017-18 Mid-Year Budget.

The budget was accepted by the Committee as a second reading on December 19, 2017. The Board subsequently approved the budget as a first reading at the November 15, 2017 meeting. This budget will become effective January 1, 2018.
