

Prescription Drug Costs




*Data is updated every month to include new claims, modifications, adjustments, and amendments to correct identified data issues by plans. Each data run is a snapshot of the data base at that moment in time. For example, 2014 total pharmacy cost extracted in 2015 would be different from those in 2016, or 2017.

**The Holding Plan is commercial or Basic prescription drug coverage that Supplement to Original Medicare members have when pending enrollment into Medicare Part D by the Centers for Medicare and Medicaid Services (CMS). Holding Plan coverage is a benefit that allows members to have full prescription drug coverage while they await Medicare Part D enrollment.








Medical Pharmacy Costs by Place of Service


