Subject: CalPERS Fiscal Year 2018-19 Annual Budget Proposals (First Reading)

In April, the Finance & Administration Committee (Committee) recommended the California Public Employees' Retirement System (CalPERS) Board of Administration (Board) approve a proposed Fiscal Year (FY) 2018-19 Annual Budget.

The budget was accepted by the Committee as a first reading on April 17, 2018. The Board subsequently approved the budget as a first reading at the April 18, 2018 meeting. If approved by the Board as a second reading in May, this budget will become effective July 1, 2018.
