The JRF II provides retirement benefits to judges elected on or after November 9, 1994. This fund is invested in a moderately aggressive asset allocation strategy.

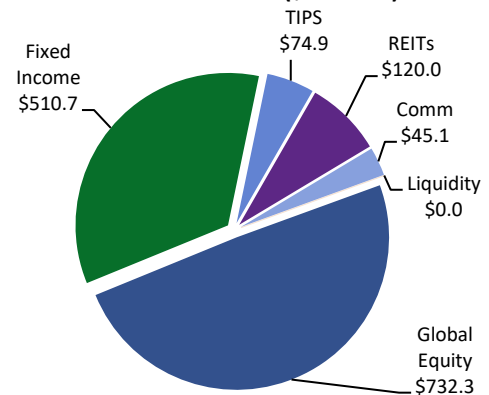

LEGISLATORS' RETIREMENT FUND (LRF)

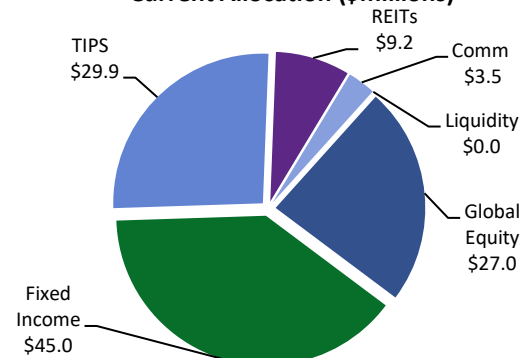
LRF Overview

This fund is closed to new membership and is invested in a conservative asset allocation strategy.

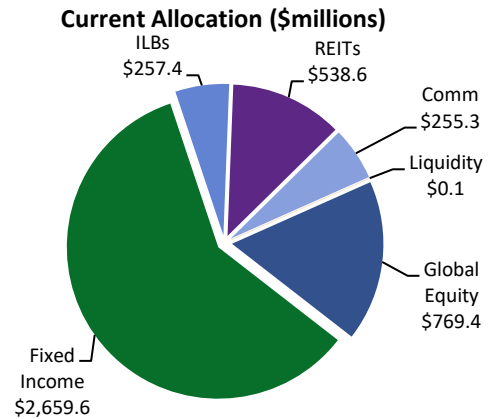

A portion of the reserves is held at the State Treasurer's Office and the remainder is 100% invested in a U.S. fixed income fund.

As of March 16, 2015, the State Peace Officers' and Firefighters' Defined Contribution Plan Fund (POFF) accounts have been closed. The pre-tax CalPERS Deferred Compensation (457) Plan is for participating public agencies and school districts. The after-tax CalPERS Supplemental Contributions Plan (SCP) is for State employees and members of Judges' Retirement Systems & Legislators' Retirement System.
