
PUBLIC EMPLOYEES' HEALTH CARE FUND (HCF)

The pre-tax CalPERS Deferred Compensation (457) Plan is for participating public agencies and school districts. The after-tax CalPERS Supplemental Contributions Plan (SCP) is for State employees and members of Judges' Retirement Systems & Legislators' Retirement System.
