Enhance Enterprise Internal Control Framework to advance risk management capabilities and provide the Board with heightened assurance.

- 60% Implement Operational Risk Event Reporting, Phase 1. (2018–22)
- 10% Establish internal control repository, including standardized cross-functional process maps to document internal controls for the enterprise-wide functions. (2018–22)

Collaborate with the programs in the identification, assessment, and monitoring of risk within the Board's appetite.

- 100% Complete the Annual Enterprise Risk Assessment.
- 100% Finalize Strategic Risk Measures that reflect the Board's appetite for risk.
- 100% Incorporate Integrated Assurance Maps into the annual Enterprise Risk Assessment.
- 10% Adapt the current Risk Management Framework for program-level risk assessment in collaboration with the Enterprise Compliance team.
 - Enhance compliance and risk functions throughout the enterprise.
- Educate CalPERS' team members and stakeholders on the importance of a risk-intelligent organization through the implementation of the ERMD Communication Plan. (2018–22)
- 30% Enterprise Data Governance: Create/enhance policies and processes to strengthen appropriately defined data-driven decisions, ensure intent is understood, and improve the consistency of data use across the enterprise which includes people, process, technology and culture dimensions. (2018–22)
