Mr. Suine provided an overview of the retiree Cost-of-Living Adjustment (COLA) effective May 2020. The United States (US) inflation rate as measured by the percentage change in the CPI-U for the 12 months ending in December 2019 was 1.81 percent. This measure will be used in calculating the 2020 COLAs for CalPERS retirees. The COLA amounts are provided in the April agenda item.
