Blue Shield Trio (Basic) Proposal

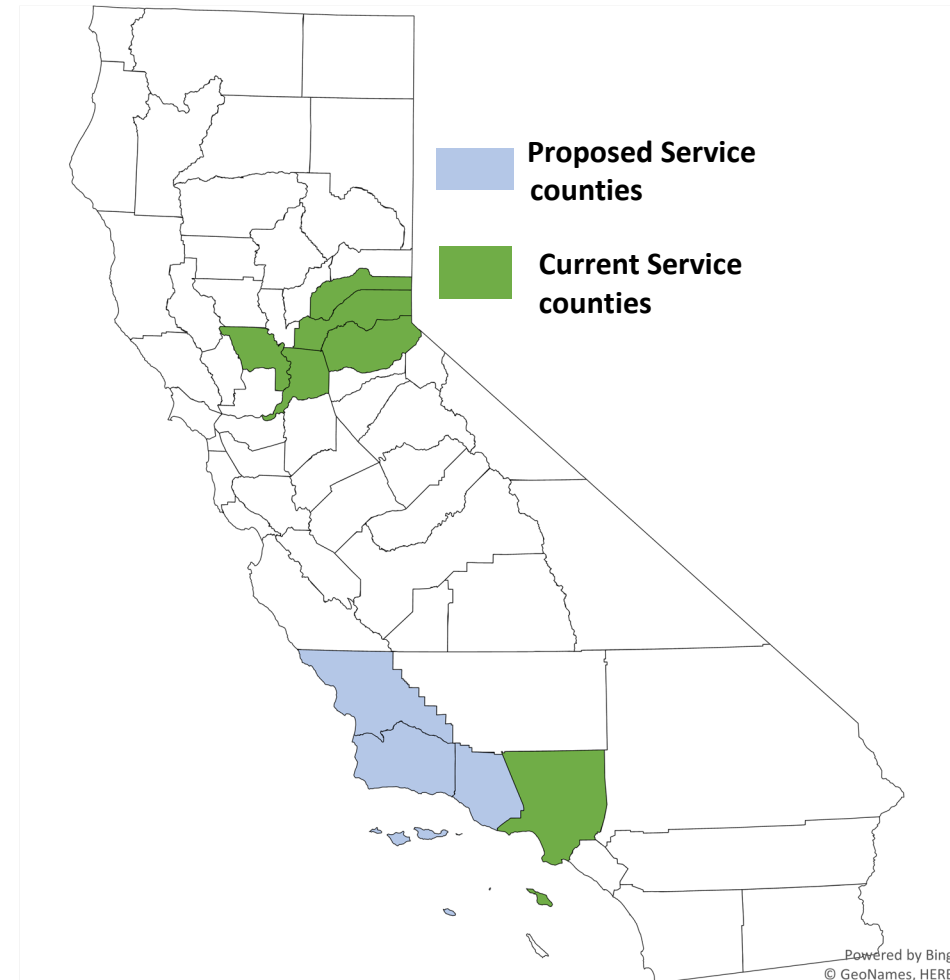
3 County Service Area Expansion

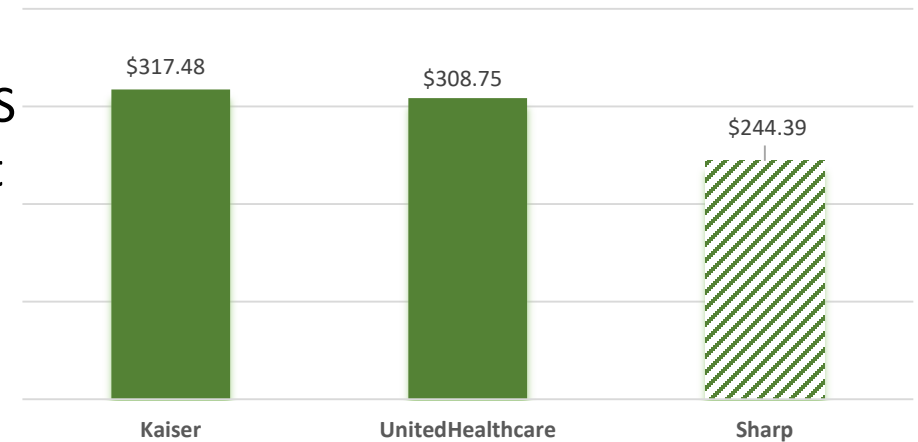
Sharp Medicare Plan Proposal
