Agenda Item 7a – Risk Mitigation Strategies: Health Maintenance Organization (HMO) and Preferred Provider Organization (PPO)

She presented options for managing risk within the HMO portfolio and the modeling for those options. In addition, the results from the Benefit Design Modeling phase of the PPO Health Plan Assessment Project were presented.

Agenda Item 7b – Long-Term Care Program Competitive Strategy

As an information item, Mr. Moulds, Chief Health Director, (HPBB), provided an update on an annual experience study the Actuarial Office (ACTO) performed ensuring assumptions made regarding the pricing of Long-Term Care (LTC) products are still appropriate and in line with industry standards. ACTO brought to the September Finance and Administration Committee (FAC) a reduction of the LTC discount rate of 5.25% to 4%, which would significantly increase premiums without mitigating efforts. This agenda item presented the mitigating efforts for stabilization currently underway.
