



# Key Changes to Advance Exceptional Health Care

## Lower Cost

- Assess fees for 4 proposals
  - Fully insured
  - Flex-funded
  - With and Without Rx
- Administrative Services Fees low relative to market
- Maximize plan and provider competition
- Innovations & education to increase engagement

## Improve Quality

- NCQA accreditation rating of 3 or greater
- New target thresholds for quality
- Focused clinical quality measures
- Financial penalties as % of premium
- Behavioral health, telehealth, and advanced primary care focus

## Advance Equity

- NCQA Health Equity accreditation
- Cultural and linguistic competency
- Health Equity Officer and program
- Screen for unmet social needs
- Member advisory committee






