On June 21, 2023, I received a copy of the Board of Administration's Decision in the above matter, pursuant to the Administrative Procedure Act, (Gov. Code 11370 et seq.) and California Code of Regulations, title 2, sections 555.555.4 on June 20, 2023.

I am requesting a review, of "The error or omission was the result of mistake, inadvertence, surprise or excusable neglect, as each of those terms is used in Section 473 of the Civil Code Procedure".

In the Disability Retirement Election Application handbook, page 11, states, "The effective date of your retirement can be no earlier than the day following your last day on payroll, as long as your application is received by CalPERS within nine months of that date. If not, the retirement date can be no earlier than the first of the month in which CalPERS receives your application". I have attached the letter stating I was permanently separated from CalPERS, dated October 30, 2020. This date justifies my separation and is within the nine-month requirement. (May 1, 2021).

Furthermore, I continued the interactive process through the year (2020-2021) until I was formerly advised through my attorney to retire. At this time, I was ill-advised of the date to put down for retirement. I respect the professionalism and authoritative position of attorneys, so I acknowledged his advice.

With the ongoing anticipation of returning to work, I was excited and inattentive to timeframes, therefore, your consideration in, the fact that I was inadvertent, an excusable act.

I am requesting an earlier retirement date of October 30, 2020, the date I was permanently separated.

6. On October 30, 2020, CalPERS sent respondent a letter stating, in part, as follows:

You have received this letter because one or more of your former employers have notified us that you have permanently separated from CaIPERS-covered employment. We are providing the information below to help you make an informed decision about your CaIPERS membership.

When requesting retirement:

- Submit your retirement application within 9 months of separating from employment to receive the earliest retirement date.
- By submitting your retirement application more than nine months after separation from employment, your retirement date can be no earlier than the first of the month in which your application was received.

On January 13, 2021, following a telephone conversation between respondent and a CalPERS staff member regarding service retirement and industrial disability retirement, CalPERS sent respondent a copy of its publication *A Guide to Completing Your Disability Retirement Election Application*, effective December 2020, which at page 12, in a highlighted box states:
