SUBJECT: 2001 PPPA FACTORS

Our actuarial staff has developed the Purchasing Power Protection Allowance (PPPA) factors for 2001. Increases (or decreases) based on these factors will be included as part of the monthly retirement warrants to those retirees and beneficiaries who are entitled to receive the PPPA benefits.

The PPPA payments are designed to restore up to a maximum of 75% of the original purchasing power of retirement allowances for those retirees with state or school service and 80% of the original purchasing power of retirement allowances for those retirees with public agency service. The percentage adjustments for 2001 are based on the United States City Average Consumer Price Index. The table shown below provides the factors for the three largest employer groups: the State, Schools and Public Agencies providing 2% of cost-of-living adjustments.
