SUBJECT: 2010 HEALTH PLAN CODE CHANGES

Introduction This Circular Letter addresses the 2010 Health Plan Code changes.

**Background** Two Health Program changes for 2010 necessitated the adoption of new health plan codes.

- 1. For contracting agencies, the CalPERS Board of Administration approved splitting the Bay Area/Sacramento region into two regions: Bay Area region and Sacramento region. This resulted in elimination of six plan codes and addition of 12 new plan codes for Basic and 12 new plan codes for Medicare.
- 2. Blue Shield of California is replacing its Supplement to Medicare plan with a Medicare Advantage plan (Blue Shield 65 Plus) in all or parts of ten counties.
  - a. For State Agencies, this resulted in two new Basic and two new Medicare plan codes.
  - b. For Contracting Agencies, this resulted in four new Basic and four new Medicare plan codes.
  - c. Note that although the Health Program change relates to Medicare, the Basic plan codes in affected regions were also impacted.
