	Presenting the 2014 CalPERS Health Plans provides employees, retirees, and their dependents information from expert representatives of each of the CalPERS health plans. Also included with this on- demand video are downloadable materials regarding the 2014 health plans.		
Why Offer a Video Alternative?	This video alternative to onsite health fairs gives participants a convenient opportunity to learn about the various 2014 health plan benefits and updates.

	<ul> <li>24/7 access to health plan information and choices available</li> <li>Consistent information to all members</li> </ul>		
	<ul> <li>Access to information regardless of employee work schedules</li> <li>Expanded access to family members involved in choosing the family's health plan</li> </ul>		
	<ul> <li>Opportunity for agencies that have limited space or resources to host onsite fairs</li> </ul>		
	• Convenient links to related health plan websites such as <i>Find</i> <i>A Provider</i> tools for in-network physicians and hospitals, <i>Find A</i> <i>Pharmacy</i> tool for in-network pharmacies and pharmaceutical formulary databases.

2013 Open Enrollment Onsite Health Fairs	CalPERS Health Plan Partners will participate in a limited number onsite Open Enrollment Health Fairs. Considerations to determine whether an onsite health fair is right for your agency are:		
	<ul> <li>If your agency hosted a well-attended onsite health fair last year.</li> <li>What methods you use to increase attendance at your health fair.</li> <li>If your agency does not require mandatory attendance by employees, what percentage of your employees would be able to attend a two-hour health fair on a specified day?</li> <li>Do your employees have access to computers and the Internet to obtain information about health benefits?</li> <li>How does the Open Enrollment period of September 16– October 11, 2013, impact your resources such as facility space, budget, or staffing?</li> <li>Does your agency have staff resources available to coordinate and promote an onsite health fair?</li> </ul>		
Scheduling an Onsite Health Fair	<ul> <li>To request an onsite health fair, follow these instructions:</li> <li>1. Send a request by accessing the onsite fair request form at www.calpersoerequest.org.</li> <li>2. Fill out the form with the information pertaining to your agency's health fair needs.</li> <li>3. Once you are done, click "Submit" and the form will be electronically transmitted to the health plan partners.</li> <li>If your request for an onsite health fair is approved, the health plan partners will coordinate directly with your agency contact regarding scheduling and logistics.</li> </ul>
