California Public Employees' Retirement System (CalPERS) is dedicated to being responsive to customers' needs. As a result, CalPERS is pleased to announce the launch of a series of Employer Response Dialogues.

In this series of small venue sessions, senior leaders from our CalPERS Customer Services and Support (CSS) Branch will engage with our employers' key decision makers and leaders in discussions on the business of providing retirement benefits to our members.

The dialogues will include an open discussion on topics selected by CalPERS and regional employers. Some topics already identified for discussion include PEPRA, Pensionable Compensation, and Working after Retirement. We will tailor the content for these sessions based on your input.
